If the sand bags, in the case of erosion are considered the quickest solution, the modular barrier were each modular unity corresponds to 70 sand bags could represent a more efficient solution. Anyway plausible were that this system, thought to erect sand-barriers (also submerged) to combat flood-and erosion damages, by means of a modular and mechanical driven filling method, as well could serve to create larger spaces of safety around other civil strategic objectives.

# Research / Innovation and Entrepreneurship

When it comes to innovation, what is the biggest challenge that you see organizations facing? (points of vue)

- The need and emphasis on innovation does not lie well with all who do not understand the process. For instance, if a staff member has a good idea, a potential Eureka moment, in order to get financial support to develop the innovation they will have to convince upper management of the financial value of the idea and be backed up by a credible business plan which would show the potential for net income over a short to medium timeframe to the company.
- The idea generator in many cases may lack the business skills to take this forward and would rely on the business knowledge of others who are usually positioned at a higher decision-making level. With mis-understandings, fear of change, potential clashes of ego, protectionism, the process inevitably breaks down and the potential innovation does not undergo development...a potential loss to all.
- One solution may be to carefully determine the value of an idea produced by a company employee, whilst also assessing the risk of investment. This could be achieved by undertaking a process of specific (innovation-related) independant evaluation, which may include a variety of stages/steps (or criteria) that require fulfilment before a decision is taken by the company to further invest their resources into the idea. Such steps could initially illuminate the originality and demand of the innovation in relation to the current market. In this way, at the primary level, all ideas would be carefully handled and valued, which largely negates the personalities involved and focusses on the business requirements.
- In terms of the development of an 'innovation' ethos in a company, I think Albert Einstein got it right when he said that "Innovation is not the product of logical thought, although the result is tied to logical structure."
- Collecting enough ideas and selecting few to invest in the best one. Such a selection framework reduces risks indeed. Yet, it should be fed with many ideas in order to select few winning ideas. A simplified formula could look as follows: Innovation = invention/novelty + success = many ideas + selection framework + implementation + marketing.

Zalau is located in the Nord-Western part of Romania, with a surface of 90,09 km<sup>2</sup> and around 64,000 inhabitants. The transport system is formed by roads and railway (only for external relations). In order to improve the mobility we designed and started to construct a beltway/ring road for transit traffic, the first stage being finished. Also we are in the stage of contracting with EU funds an Inteligent Traffic Management System project, but this projects doesn't cover the public transport or the cycling system.

The public transport fleet consist in 46 buses,7 main routes, 2 secundary routes. At the city level there are some unsolved issues regarding the mobility, noise, air pollution. The main purpuse of the project:

a) the design of a sustainable urban transport strategy/plan, specific to the local conditions in order to improve the accesibility, mobility and pollution reduction, including:

- acces restictions policies specialy in the city centre;

- promoting and improving the public transport system, acording with the public needs: optimisation of transport route, transport capacity, transport programs, time efficiency, apropriate infomobility tools;

- policy options for freight distribution;

- policy for trafic transit;

- city cycle and walking routes;

b) the implementation of some elements of this plan, such us: clean and energy efficient busses for public transport, inteligent public local transport and walking management system (to be integrated in the existing ITS project), introducing new and modern way to inform and communicate with the clients of the public transportation system (digital panels with real time information in the most important stations,etc), e-ticketing, access restrictions policies (including a pedestrian area in the city centre), video surveillance cameras in buses, other measures to promote and improve public transport and cycling, etc.
